

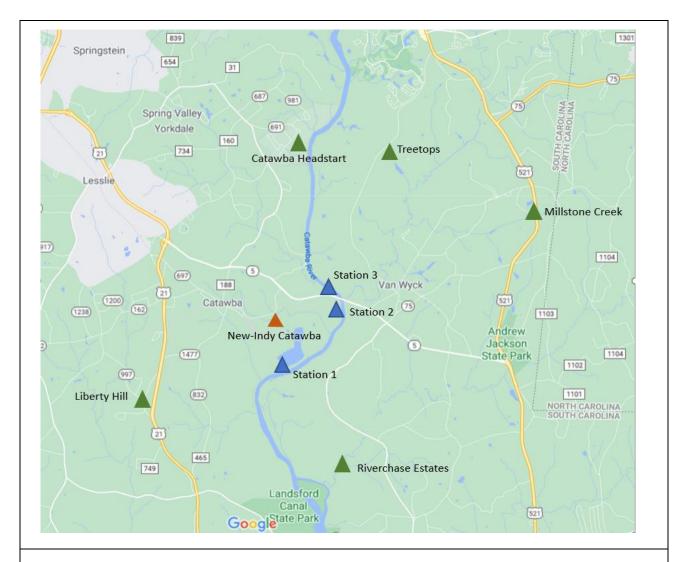



Below are graphs for offsite locations where hydrogen sulfide (H₂S) was detected during the current reporting period.



Winds were coming from a variable direction throughout the day at 1 to 8 mph.






Liberty Hill - 4/14/2023






