

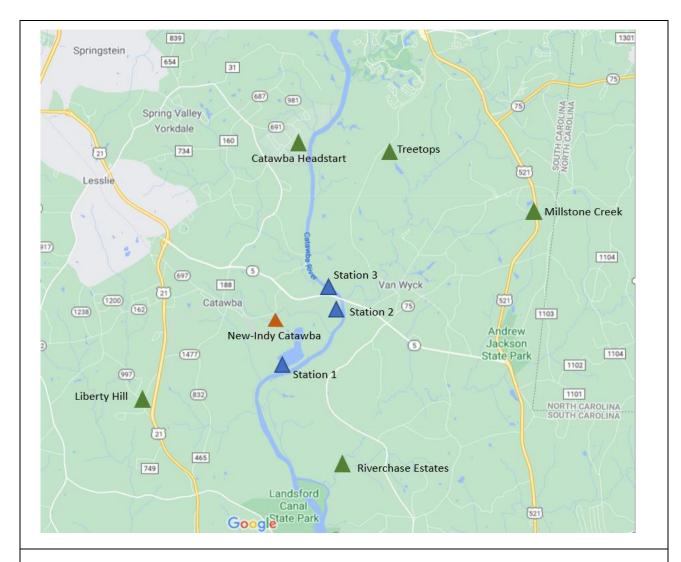


### Period H<sub>2</sub>S Monitoring Hydrogen Sulfide Offsite Monitors






