





Below are graphs for offsite locations where hydrogen sulfide (H₂S) was detected during the current reporting period.




Winds were predominantly coming from the south-southeast, south, and south-southwest direction throughout the day at 1 to 3 mph.




Treetops - 9/3/2023








Riverchase - 9/3/2023



Millstone Creek - 9/3/2023








