




Period H₂S Monitoring Hydrogen Sulfide Offsite Monitors

Below are graphs for offsite locations where hydrogen sulfide (H₂S) was detected during the current reporting period.



Winds were predominantly coming from the south-southeast, south, south-southwest, and southwest direction throughout the day at 1 to 5 mph.




Treetops - 11/8/2023




Liberty Hill - 11/8/2023






