

DYNAMIC MONITORING FINDS OTHER ODOR SOURCES

New-Indy Catawba engaged <u>Trinity Consultants</u> to collect and analyze data starting in September 2021 to determine whether there is a link between odor complaints and hydrogen sulfide (H₂S) data collected by monitors installed in the region. Trinity, an international environmental expert, also was asked to determine what were the most likely sources of odor. Trinity identified more than 30 possible odor sources and concluded, based on monitoring data and simulations, that New-Indy is not responsible for odor complaints or H₂S readings in the community 79 percent of the time. As a result, and in the public interest, New-Indy decided that additional air monitoring for H₂S should be conducted at the other possible odor sources.

New-Indy Catawba engaged Palmetto Environmental Specialists (PES) to conduct mobile air monitoring at these other odor sources. PES is a South Carolina company founded by Daphne Neel, a long-time (and now former) bureau chief for the South Carolina Department of Health and Environmental Control (DHEC). Using a Honeywell SPM Flex Single Point Monitor Gas Detector and sampling methods consistent with the field techniques Daphne used at DHEC, PES undertakes a monitoring circuit several times a week at these locations. The detector PES uses is the same meter DHEC uses for monitoring at Catawba Express on Highway 5 and is reported on DHEC's website.

The dynamic monitoring results and atmospheric conditions are recorded in PES's field logbook and reported to New-Indy on a weekly basis.

The 30-minute exposure limit for H₂S set by the Environmental Protection Agency and the Agency for Toxic Substances and Disease Registry is 600 parts per billion (ppb) and the 14-day exposure limit is 70 ppb.

The dynamic monitoring has recorded H₂S readings in the vicinity of the below locations:
