



Below are graphs for offsite locations where hydrogen sulfide (H₂S) was detected during the current reporting period.








Treetops - 7/24/2024 ——30min Avg Conc. 70 ——60 ——70








Riverchase - 7/24/2024



Millstone Creek - 7/24/2024








